(2000-2010) Keyword:"アルカイダ"

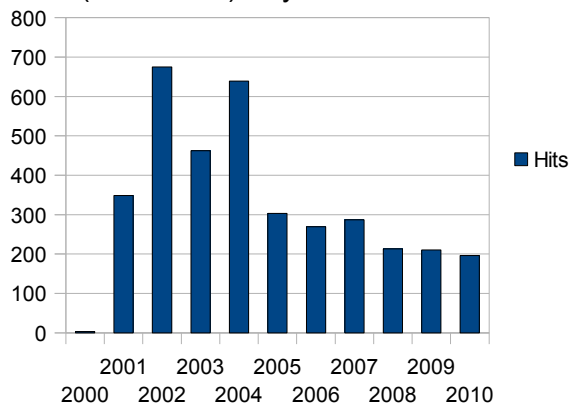

Al-Qaeda has adequate strength, not too strong, not too weak.

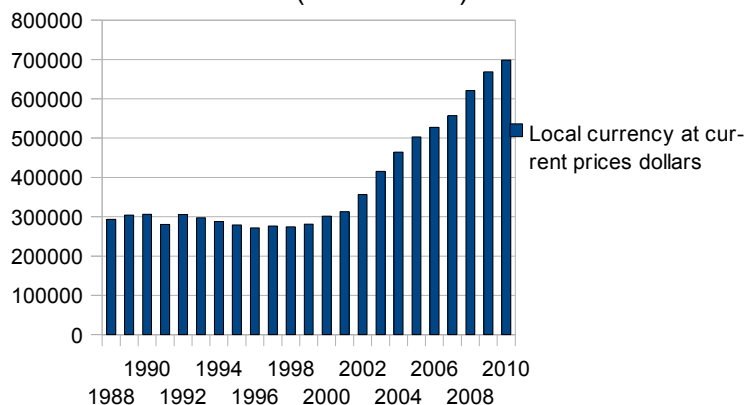
The relation between the United States and Al-Qaeda is

(1988 - 2010)**

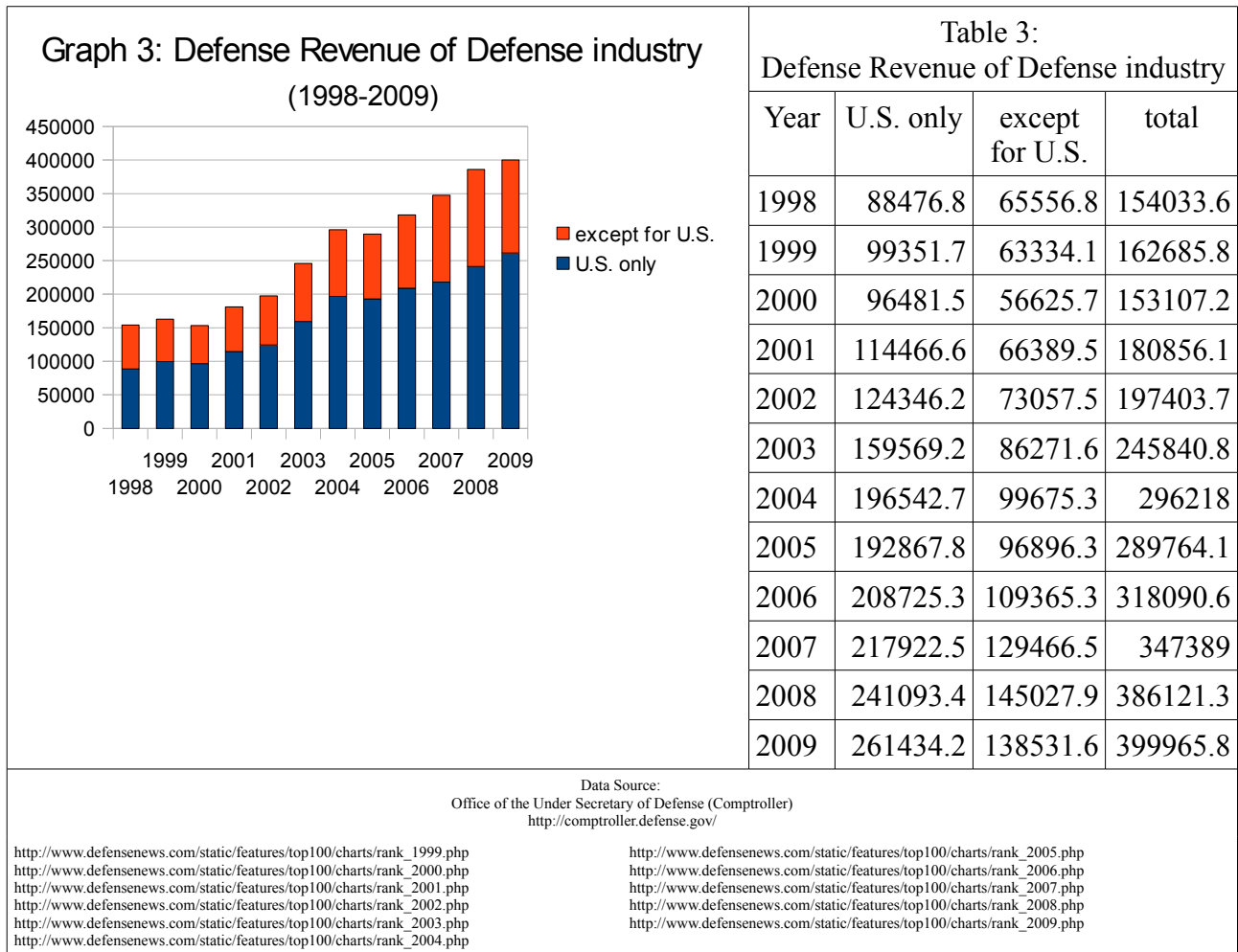

(2001/1-2011/5) Keyword:"アルカイダ"

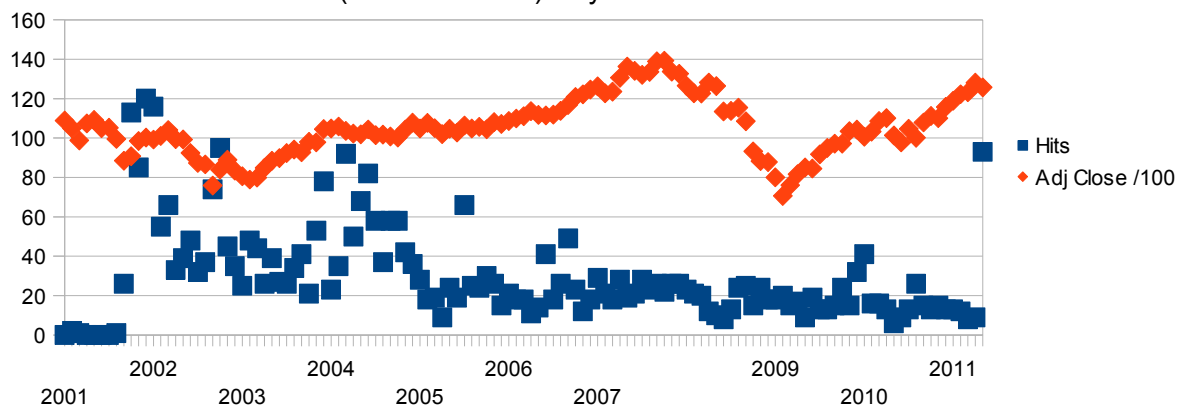
